Student Computer Loan Agreement

Parent/Guardian Responsibilities

Your student has been issued a Macbook Air computer to improve and personalize his/her education this year. The replacement cost of the MacBook Air is approximatley \$1100.00. As a parent/guardian you are responsible for the following items listed below. No alteration to this agreement is permitted and failure to sign this agreement in its' present form will forfeit the students right to take the MacBook home.

- It's the parent/guardian responsibility to supervise the student's use of the Macbook at home.
- It is suggested that you discuss your family's values and expectations regarding the use of the Internet and email at home. Any rules regarding the students use of the computer at home is the responsibility of the parent/guardian.
- All alterations and/or repairs or buying of replacement parts to the Macbook, must be authorized by the school, to repair or buy replacement parts, nor will I attempt to clean it with anything other than a soft, dry cloth.
- I will report to the school any problems with the Macbook.
- I will not load or delete any software from the Macbook.
- It is the responsibility of the parent/guardian to return the Macbook to the school when requested and upon the graduation/student's withdrawal from Alma High School.
- * It is the responsibility of the parent/guardian to pay for any damage of school equipment.

Student Responsibilities

Your Macbook Air is an important learning tool and is for educational purposes only. In order to take your Macbook home each day (7-12 students only) or use it at school, you must be willing to accept the following responsibilities.

- When using the Macbook at home, at school, and anywhere else I may take it, I will follow the policies of the Alma Public Schools— especially the Student Code of Conduct—and abide by all local, state, and federal laws.
- I will treat the Macbook with care by not dropping it, getting it wet, leaving it outdoors, leaving it the car, or using it with food or drink nearby. I understand that I will not receive a loaner computer if I damage my computer unless it is for warranty work.
- I will not load any software onto the Macbook.
- I will not remove programs or files from the Macbook.
- I will honor my family's values when using the Macbook.
- I will not give personal information when using the Macbook.
- I will bring the Macbook to school every day with the battery recharged.
- I agree that e-mail (or any other computer communication) should be used only for appropriate, legitimate, and responsible communication.
- I will keep all accounts and passwords assigned to me secure, and will not share these with any other students.
- I will return the Macbook when requested and upon my withdrawal from Alma High School
